9. Purchaser shall make available to the Disc Jockey the place of performance at least **1.5** hour(s) prior to scheduled performance time for the purpose of setting up and sound balancing. A suitable electrical outlet must be made available to the disc jockey.

The agreement of the Disc Jockey to perform said services is subject to his/her proven detention by sickness, strikes, adverse weather conditions, acts of God, or any other legitimate condition beyond his/her control for which The Disc Jockey will not be held responsible for any loss incurred by Purchaser as a result thereof. Under these specific circumstances the deposit is refunded to Purchaser. Cancellation by purchaser for any reason does not warrant return of any deposit paid.
